

# IBEW LOCAL 159 DECEMBER 2021



Greetings 159 Family,

I want to thank all our members who attended the November 11 membership meeting. It was a great opportunity to celebrate Veterans Day and share a Thanksgiving meal, with plenty of leftovers for members to take home. Remember, **December 9, at 5:30 is our next union meeting, and last union meeting at the Labor Temple**. It will be our pin ceremony and holiday party with lots of extra raffle prizes and some great food for all to enjoy. Then after the meeting, drive through Fantasy In Lights at Olin Park. **Starting in January, our union meetings will be at IBEW 159: 4903 Commerce Court, McFarland.** Also starting in January we will have boxes in the vestibule for non-perishable food items, personal hygiene items, new or gently used winterwear (adults and kids, mittens, gloves, scarfs, jackets, coats, boots, sweaters) to be donated.

In the future, I would like to have a community area at our current (and future) building that would provide our members with some resources for food, personal hygiene items, tools, work clothes and boots etc. that our members --especially new CWs and apprentices-- could use to help offset their living expenses as they begin their careers in Local 159.

To celebrate our apprentices and National Apprenticeship Week, Local 159 had an open house on November 16. The event was well attended and all our apprentices left with a raffle prize, thanks predominantly to Sister Cassie Schuler who worked hard soliciting prizes for the event. Thanks also go out to Sisters, Rebecca Schave and Leah Dye who helped with set up and clean up and everything in between. Thanks to Milwaukee Tool (Ian Blankenmeyer) for the demonstration table and donation. It was a great opportunity for our members and the public to tour our classrooms and training center, and for us to see the reality of needing to provide our members with a space to grow our training, and give our members the tools to keep advancing their skills.

Thank you to our members who have stepped up to be new (or returning) instructors. We are always looking for individuals interested in teaching or assisting, as well as people to be trained as test administrators. If you are considering this, please contact me and I will send you a form to complete with your area of interest to teach or assist.

The week of November 8, I attended the quarterly IBEW/NECA State Apprenticeship Trust meeting and the IBEW Pension Trust meeting. At this time there are no major changes being considered in either trust. There are currently 880 apprentices in all IBEW Inside Locals, exempting Local 494 that does not participate in the statewide trust. Local 159 currently has 13 VDV apprentices: 11 white males, 1 female and 1 Asian or Pacific Islander male; 247 Inside apprentices: 223 white males, 24 females 16 minorities consisting of: 1 American Indian or Alaskan Native; 3 Asian or Pacific Islander; 9 Black; 3 Hispanic.

Currently the breakdown of membership for 159 is as follows: Retirees 260 (number is based on members drawing IBEW pension); JIWs 715, Inside Apprentices 247, Residential workers 9, VDV Technicians 65, VDV Apprentices 16, Installer Trainees 17, CEs 32, and CWs 112.

I want to thank all the members who came to the Apprenticeship meetings to voice their opinions and explain to the committee the value you saw with rotation and some of the very negative effects they are seeing for our apprentices. This matter is currently with the

Bureau of Apprenticeship Standards for review, because of the deadlock between labor and management. I will keep you informed.

The Pension Trust is considering some modifications on how disbursements can be taken, which could offer more choices for our members in the future. The new Summary Plan Descriptions will be printed next year after any possible changes/modifications are finalized. There are currently 1,462 total participants in the plan. The average participant balance is \$238,577. Total balance of all participants is over \$369 million. Our funds are doing well and continue to see growth. In early 2022, we will start holding both in-person and virtual seminars for retirement and Health and Welfare for our members to attend. Prudential does offer many online seminars our members can watch when they login. They are available anytime. Members also need to know: when you retire you can leave your money in your Prudential account. Fees are lower, and you have all the options for investing. Some members think they HAVE to move it out, but that is not accurate.

Congratulations to our State workers who successfully voted to recertify their election for union representation! We are continuing efforts to organize some media coverage, informing the general public that even though wage increases have been "negotiated" for our state workers, they continue to face delays in receiving those increases

I continue to receive calls from members regarding positive COVID-19 cases on jobsites. Many times members are not finding that out from their employer, and now that there is no compensation for workers who are off due to COVID-19, some members choose to go to work sick and are infecting co-workers. We all know the varying opinions and points of view regarding COVID-19, vaccinations, masks and social distancing. We are still a very long way from "normal" and there will continue to be division on this issue. I want our members and their families to be safe at work, school and beyond, to be able to enjoy the holidays and be respectful towards one another. No one can force their opinions on anyone and expect to change their mind or behavior. So, as we look forward to the upcoming holidays and a New Year, maybe a little soul-searching and personal reflection will help us all find a better way. Hate and division cannot replace tolerance and respectful dialogue. We can all do so much better, and we need to for the sake of our own mental health, our families and our Country. our Annual External Audit is complete. Our Consolidated Financial Statements are available to review in the office.

our Form LM-2 was reviewed by our Treasurer and our President and has been submitted before the September deadline. This Form is a public disclosure and can be reviewed online or in the office.

The last filing deadline we face is our annual Tax Return Form 990, has been filed by Wegner CPA's. This form is also available as a public disclosure and can be reviewed in the office.

Now the fun part: comparing the numbers from June 2020 thru July 2021. On June 30, 2020 the total assets were \$5,431,812.00. One year later, July 31, 2021 total assets were \$5,943,764.58; an increase of 9.4%.

At the beginning of January, anyone who received a paycheck from Local 159, will be sent a W-2 form. All W-2's must arrive to the employees by January 31.

You can always call the office to verify if you are current on death benefits. One way to stay current with your Death Benefits is to add an extra dollar to your monthly union dues payment.

Always contact the office if you have any changes in your contact information – mailing address, phone number and email. Please make sure we have the most updated information on your beneficiary form on file for you.

There are a couple of things I want to mention:

- All first year and second-year apprentices get reimbursed for their Electrical Apprentice license fee.
- SNAPZ -- Are you looking for help to pass the JW or master's test? Would you like to learn more about reading and understanding the NEC? Contact the hall for information on accessing our free SNAPZ online practice tests.

#### Meet a Member of Local 159 -Jim Virnig

**Shops where Jim worked:** Kaeler Electric, Capital Electric, Academy Electric, Westphal, H & H, and also worked for the State, downtown covering the GEF and administration buildings. Also worked on the road at Byron, IL.

While working for the state during the Governor Lucey era, I put security in the Governor's Mansion to guard the wine cellar. With Capital Electric they did a lot of houses for Midland homes. I worked with Bob Call. He was a good guy to work with. Then went to Academy. Worked on Monona Shores.

**People would never guess:** I used to teach horseback riding, during high school. Before the Alliant Energy Center was built, there was a horse stable there. Later on, I started working at Alliant Energy Center, and wired the exhibition hall. And I began working there at events. I retired a decade ago, and I was still working at the Alliant Center until COVID, when I was furloughed.

In addition to helping with Fantasy in Lights, Jim has done a lot of volunteer work over the years, including wiring houses for Habitat for Humanity, and tutoring local school kids with reading. He still volunteers at Habitat ReStore on Odana Rd. He volunteers annually at the Building Trades Council's Take Kids Fishing event. We hear them. We also hear your questions.

#### **Questions from Local 159 members**

<u>If an employer requires vaccination for employment, is that legal, and must I comply?</u>
Yes, employers can do that. Whether you comply is up to you. It may decrease your employment options.

<u>I got vaccinated to meet employer requirement, but there is a worker on my jobsite who is not.</u> Whose responsibility is that?

If employers require vaccination, it is their responsibility to ensure workers are vaccinated. If you have a concern, contact the Local 159 office for confidential assistance.

#### If I am quarantining due to possible exposure, is there coverage?

At this time, quarantine takes place on your own time. It is still worth applying for Unemployment but be aware you may not receive it.

#### How long is the quarantine period, if I am exposed to COVID?

#### I tested positive for COVID, and will be off work for a while. What can I do?

You can apply for short term disability (26 weeks per instance). First week is not paid. Contact WEEBF. It is also possible to take an early distribution from your retirement, if it has been at least six months without making a contribution. There are provisions to meet. See "Retirement" at weebf.org, and/or contact WEEBF.
